➤ L. Gerstenslager presented the 3rd quarter reports, explained the monthly and quarterly financial overviews and documentation that occurs and the roles that each team member plays. A discussion was had about how the grant contracts impact the amount of contract management and how working on shared services for technical application may be a better formula working with the local municipalities to complete some of this work, verses the District completing all components of a project and then having no local buy in for the long term operations and maintenance of a project.

Old Business:

➤ Update: Survey Equipment: GPS Unit: Featherstone Supply-L. Gerstenslager informed the Board that staff had completed several surveys with the new equipment and are pleased with results. Technician C. Hotto has transferred imagery to GIS and the District is looking at cross training 4 of the employees to continue to extend the use of the equipment. M. Humbert inquired if ACAD was owned and being used and at this time is not. All drawings are done by hand. L.

- Gerstenslager informed the Board that it was a training tool that was being considered in the spring to possibly inquire something to be offered by FLCC for multiple Districts.
- ➤ 2018 Proposed Wayne County Budget Review-October 24, 2017-L. Gerstenslager stated it went as well as it could have and we will have to wait to see how the finance committee works out.
- ➤ Conservation Skills Workshop R. Thorn gave an overview of the training and how the staff seemed to get information from.
- ➤ NYACD P. VanLare reported on the events of the meeting. She indicated the classes were very good but there is a level of frustration on how the resolutions and business meeting were handled. Things that are noted for the future.
- Change in Plan of Work for Part C- L. Gerstenslager requested some of the remaining Part C funding be allocated to support the Part B project. The project ended up having a few more opportunities to manage and mitigate some of the erosion occurring from the abutment structures in Canandaigua Outlet.
