- A. County Contract Updates: Ron Thorn:
 - 1. Harvesting: Budget is almost complete. Waiting for repair bill for clutch on truck.
 - 2. Drainage budget was used up as well as Part B. Part C is being used to complete projects outstanding.
 - 3. Household Hazardous Waste event went well, but under attended. Will look at different sites and more advertising for next event. E-waste is scheduled for December 4 & 5.
 - 4. Septic has an application pending.
 - 5. REDI Eastern Barrier Bar: Project is underway.
 - 6. REDI Port Bay is still going thru permitting process. DEC has had questions.

- B. Grant updates: Ron Thorn:
 - 1. Ag NPS: Humbert will need an extension.
 - 2. CRF: Harper is complete. Round 8 getting ready to open.
 - 3. AEM: Three projects are finished and 3 more will be done in the spring.
 - 4. FLLOWPA 22 and 23 are getting ready to close out before the end of the year. A dump truck for the AVC program was purchased using FLLOWPA funds.
 - 5. EFLC: Still moving forward. Questions for bonded portion of funds were being sorted out.
- C. District Technician exam has been scheduled, but results could take 3-6 months. We can hire provisionally. Six people have signed up for the exam. We have several applications and plan to set up interviews in December.
